## CHOOSING A COMPANY TO PROFILE


- The best way to develop your research skills is by doing it!
- We recommend 'following along' with a company that you are researching.
- You may already be resisting a company as part of a campaign.
- If not, choose a company that interests you. The larger companies, like G4S, may be easier to find information on.

## WHAT DOES THE COMPANY DO?

- Start with the very basics.
- Where is the easiest and most simple place to start to help you understand what a company does?
- Look at the company's website. Read its about page or its 'what we do' page.
- If no website, utilise Companies House and other tools in this course.

## ANNUAL REPORTS

- An Annual Report is a company's yearly report to shareholders, documenting its activities and finances in the previous financial year.
- Mostly used by large companies and PLCs.
- Beware of the spin! A report is designed to make the company look as good as possible.



## ANNUAL REPORTS

- Generally contains a description of what the company has been doing and its annual accounts.
- Download the company's annual report from their website.

## UNDERSTAND THE COMPANY'S CORE BUSINESS

- What does it sell?
- What are its main products, services or business lines?
- Does it have any key brands or trademarks?
- Don't assume you know a company's core business because of their front-facing brand.



## WHERE IS THE COMPANY BASED?

- Where is the company's head office?
- Where are its offices, factories, plants etc?
- Does the company have other offices?



## WHERE IS THE COMPANY ACTIVE?

- How to find company locations:
- More often than not, company locations can be found on the company's website.
- If not, locations are often listed in Annual Reports.
- If not, you may need to find them through their annual accounts filed with Companies House and through mapping their subsidiaries (coming later).
- Web searches can also reveal locations.




